NPTC/J.J. KELLER WEBCAST SERIES

Last month, NPTC and J.J. Keller & Associates teamed up once again to host two safety-related webcasts. The webcasts, which are free to all NPTC members, focused on:

March 21—Driver Qualifications

What is meant by driver qualifications? There is a large body of regulations devoted to what is involved with qualifying a driver, specifically sections in Parts 382, 383, and 391. However, there is much more to "qualifying" a driver than following the regulations.

In this webcast, we discussed the policies and procedures a carrier should have in place to make sure that it is not hiring an unqualified driver or its next

problem. The special fleet speaker was Michael Mason, transportation manager at Nestle USA/Nestle Transportation Co.

March 22—Medical Qualifications/ Sleep Apnea

There are many regulations, best practices, and processes in use for hiring safe drivers at carriers. One key step in any hiring process is conducting thorough background checks. The webcast covered the required as well as optional background checks a carrier should consider using to make sure it is hiring safe drivers. Our special fleet speaker was Greg A. Sikorski, director of transportation safety and compliance at KeHE Distributors.

2018 BENCHMARKING SURVEY

This year's Benchmarking Survey Instrument was sent to the general membership in February. The annual NPTC Private Fleet Benchmarking Survey is sponsored by PeopleNet and is designed to validate private fleet

performance based on comparative peer data, identify areas of improvement and opportunity, and identify the significant trends affecting private fleet practitioners. The final report will be released August 1.
