



## **"I WOULD GLADLY GO THROUGH PFMI** AND CTP PROGRAMS AGAIN"

TEVEN ROBERTS, CTP, IS A 22-YEAR EMPLOYEE AND FLEET MANAGER OF DESERET TRANSPORTATION, the private fleet of The Church of Jesus Christ of Latter-day Saints. The word "deseret" means honeybee in the Book of Mormon-a symbol of industry. Steven is a Board Member-Elect of the NPTC Board of Directors, a Faculty Member of the Private Fleet Management Institute, and frequent speaker at the NPTC Annual Conference and National Safety Conference.

Steven was born in Washington State and raised in Utah. His mother grew up in Bronx, New York, as a Lutheran, graduated from Hunter College, and went to work for the Anaconda Mining Company in Grants, New Mexico. There she met Steven's father who was raised in a nearby community that was settled by members of the Church of Jesus Christ. He also worked at Anaconda. They married and had seven children, a girl and six boys (Steven is #3). His father took a job with Shell Oil and the family moved to Anacortes, Washington, then later moved to Salt Lake Valley where Steven was an honor student, played in the school band, sang in the choir, and played football and basketball.

After high school, Steven enrolled in Brigham Young University. He attended school for one year then went on a two-year mission to Puerto Rico and the Dominican Republic for the Church of Jesus Christ.

After the mission, he returned to BYU, met his future wife (they have three adult children), and earned a degree in Chemical Engineering. Very few chemical engineering jobs were available at the time due to a global oil glut and economic downturn. Steven worked as a civil engineer for a few years, then returned to BYU for an MBA degree in Operations and Supply Chain.

Upon graduation, he took a position with the Welfare and Self Reliance Services Department of the Church of Jesus Christ, starting in strategic planning. In 2001, he moved to Deseret Transportation and has been there ever since. "Transportation is a great industry made up of great people," said Steven. "I feel fortunate to have made it my career."

Deseret's fleet consists of 17 staff including maintenance shop personnel and 41 drivers. "Our trucks kept moving during COVID," said Roberts. "Demand was high, but we did not change any routes. Fortunately, we did not have a case of COVID in our group until November of 2022."

Since COVID, the company has begun to transition from an OTR to a regional operation and a "hub and spoke" system. "It's easier for us to find local drivers compared with long-haul operators which are much harder to recruit. We now give our drivers more home-time during the week and more weekends at home with their families. We don't drive at all on Sundays. All drivers are members of the Church and spiritually aligned with our welfare mission to assist people in need which the fleet helps fulfill," said Roberts.

Most products and goods distributed by the fleet are produced by the Church which owns a flour mill, canneries, ranches, orchards, processing plants, warehouses, grain elevators, and farms. The focus is on mostly staples like fruits, vegetables, grains, turkeys, beef, and milk. Items not produced include chicken, cooking oil, tuna fish, toothbrushes, razor blades, and similar items, which are sourced from outside companies.

"The fleet manages only a small number (250) of SKUs," says Roberts, "but the inventory is selectively focused on years of need, not days and weeks. During the COVID crisis, we did not run out of toilet paper." The fleet does not have for-hire authority and handles 85% of the Church's freight. Some 10%-15% of loads are outsourced."

Shipments delivered go out to the Church's "bishop storehouses" (similar to local food banks) at locations across 45 states. The storehouses are run by member volunteers. Food, clothing, and household supplies are provided to Church members and others in need. "Distribution has increased substantially to charitable organizations, like food banks and community centers, servicing at-risk people in need," said Roberts. "We are doing bi-weekly shipments to indigenous communities in South Dakota. They don't Continued on next page

have access to regular grocery stores and do most of the shopping at convenience stores."

In 2020, the Navajo Nation living in remote regions of Arizona were really hard hit with the COIVD pandemic. The Navaho Tribe requested the Church's help. "We delivered several loads of fuel (wood) and food supplies to the Tribe's "chapter houses" which operate like community centers," said Roberts. "Some were 60 miles from a convenience store. Some did not have paved roads. But our drivers made it in and out safely."

The Church's distribution system prepares for future emergency needs like disaster relief from major weather events. Roberts says that Deseret Transportation management group had a "vision adjustment" in recent years to make the fleet's priority focused on hard-to-handle or hard-to-broker freight, or freight with special handling requirements or tight windows. "We have the capability to respond within hours with disaster relief."

In 2015, Steven started attending NPTC's Annual Conference and National Safety Conference. In 2020, he participated in the Private Fleet Management Institute and sat for his CTP exam. Three weeks after he took the exam, everything shut down due to COVID.

"The Council is a great resource for me to meet other fleet managers and gain a better handle on the private fleet business," says Roberts. "The benchmarking report is an especially valuable part of NPTC services. It gives us a deep dive into our own operation as compared with other fleets."

"The CTP program has given me a breadth of knowledge which has been extremely helpful in managing our fleet. Going through the CTP training was like being back in school. It made me stretch and apply different tools from the core disciplines. The experience made me think about how all the issues are related. CTP was a great time in my career."

"I would gladly go through the PFMI and CTP programs again."

#### CTP EXAM RESULTS

THIS YEAR, AS WE CELEBRATE THE 30TH ANNIVERSARY OF THE

CERTIFIED TRANSPORTATION PROFESSIONAL PROGRAM, we

had 142 candidates that sat for CTP Exam. Of those, 116 passed – a passing rate of 81% which is down from last year's 88% pass rate but brings us back in line with our historic average of 76-80%.

Of those that did not pass:

6 Failed both portions

11 Failed the case study portion only

7 Failed the short answer essay portion only

On the retake exam, we had 23 candidates who passed. That brings the CTP Class of 2023 to 139 – the largest class in the 30-year history of the program.

Also, of note, we had a record 107 CTP volunteer graders participating. That gave us a total of more than 1,000 individual grades recorded for both the case study and the short answer essay. This means that each candidate's exams were read by an average of eight CTPs, infusing the process with a high degree of fairness, corroboration, and integrity. It was also a great way for so many CTPs to earn 25 recertification points and we heard nothing but good feedback from those existing CTPs that participated in the process.
