## "A RISING STAR"

AYLOR WISE, CTP, ASSISTANT TRANSPORTATION MANAGER—ADMIN, WITH DOT TRANSPORTATION, WAS HONORED THIS PAST APRIL AT NPTC'S ANNUAL CONFERENCE AS THE "TOP GRADUATE" of the Certified Transportation Professional ® (CTP) Class of 2022, an award sponsored each year by Fleet Owner Magazine.

Raised in Concord, a small village of 150 residents in western Illinois, Taylor's career intent was to be a biologist for the Environmental Protection Agency or Bureau of Land Management. Taylor

was a top student in high school, class president, and cheerleader all four years. After graduation, she enrolled in Southern Illinois University — Edwardsville - and earned a bachelor's degree in biology and is completing a master's degree in biology - plant ecology with a special interest in invasive plant species.

While working on her graduate degree, Taylor served as a biological science laboratory teaching assistant helping promote learning and development of entry-level biological science students by leading hands-on laboratory classes.

Her introduction to transportation began when she accepted a position while going to school as package dispatch supervisor for UPS where she supervised daily activities of package handlers and drivers including planning and organizing daily routes for distribution. "I really enjoyed the people and was ready for a full-time opportunity," Taylor said.

After a few years, she accepted a Management Trainee position with Dot Transportation, working and training with various teams and individuals to learn about core functions of Dot Foods and understanding how the internal and external services provided contributed to the success of the company.

"This was a tremendous job," said Taylor. "I fell in love with what I'm doing."

She was promoted in early 2021 to Assistant Transportation Manager and now manages the Dot Transportation administrative payroll team for DOT drivers and owner operators helping provide quality customer service for drivers covering payroll issues and related driver questions.

When Taylor signed up for the Private Fleet Management Institute, she had no preconceived expectations and was not too wor-

ried except for time constraints. The first day, however, she thought, "Oh, no, this is overwhelming. I knew it would be more of a time commitment than I expected. At that point I decided I was going to be a sponge."

"PFMI leader Tom Moore emphasized looking at the ways others are doing things. Our Dot Transportation ways are successful but other companies are doing things differently and are also successful. PFMI taught me to see success in more than one way. It was awesome learning about alternatives."

At PFMI, everyone was speaking out and sharing information. It was all so very beneficial. I brought a lot of stuff home which I'm

still unpacking."

"All the attendees were serious about being there and keen to learn from one another. They were, to a person, top quality individuals across the board. Fleet and allied/suppliers were all excellent. I did not feel like I was being sold something from any of the allied people. Conversations among attendees were at a professional grade level. Tom warned us in the beginning it would be like drinking from a fire hose. It was!"

Taylor said that after eight years of studying biology at the undergraduate and graduate level, she felt confidence as a test taker.

"The CTP exam was probably the hardest test of my career. From the sheer volume of material to the time allotted to answer questions, the exam was a unique challenge in my experience. Only three out of the five core subject matter topics covered by the CTP applied to my job. Finance was the hardest part for me; fortunately, I focused on the hardest stuff first."

"The special thing about NPTC and becoming a CTP is being around people who are passionate about what they do and excited to be a part of the Council's culture.

After the CTP graduate ceremony with my CTP Class of 2022, and after a few days of attending workshops and roundtable discussion sessions at the Annual Conference, I collected a stack of over 30 business cards of colleagues I met at the show who are now part of my business network. And from my CTP class, I have 77 fellow graduates and contacts I can reach out to and keep the flow of ideas and insights going."

So for the last 20 years, Auto-Zone has taken a unique approach to backhaul by partnering with its trusted vendor community. AutoZone works with key vendors and uses a combination of our private store delivery fleet and 3PL carriers to pickup/haul inbound product to AutoZone's 10 distribution centers. Half of all inbound freight is moved this way allowing better visibility of purchase orders and improved lead times over vendor managed freight. A cross dock process combines these orders along with other AutoZone freight for more than 80% efficiency on daily outbound loads. This combination of AutoZone drivers and carriers allows the private fleet to be flexible with business needs so there is always capacity for on-time retail store deliveries. With operating at less than 1% inbound and outbound empty miles, the AutoZone private fleet has brought great value to the total business.

# NPTC WELCOMES FOUR INTO **DRIVER HALL** OF FAME

OUR DRIVERS, WHO COLLECTIVELY HAVE DRIVEN FOR MORE THAN 165 YEARS WHILE RACKING UP NEARLY 15 MILLION MILES OF SERVICE without a chargeable accident or a moving violation, have been inducted into the NPTC Driver Hall of Fame sponsored by Navistar NEXT eMobility Solutions. The recognition took place in conjunction with the NPTC Annual Education Management Conference and Exhibition, which was held April 10-12, 2012 in Cincinnati, OH.

The drivers are from NPTC member companies and have met the minimum qualifications of 20 years, three million miles or 50,000 hours of driving without a preventable accident. Many of the drivers have far exceeded these qualifications and are known for having made significant contributions to their industry and their communities. Since its inception, 112 drivers have been installed in the Driver Hall of Fame. This year's Driver Hall of Fame inductees are:



#### **PATRICK FAY** Core-Mark International

Pat started his driving career in 1983, and in those 39 years has racked up 2.2 million miles. Pat began with Carver Trucking and then joined Gene Dischler Trucking, hauling everything from livestock

to seed, grain and chicken manure. He eventually switched from part-time to full-time truck driving, and his career took off. In 1998, he went to work for Farner-Bocken (now Core-Mark International), racking up 24 consecutive years of safe driving pins. Pat typically drives up to 400 miles per day and his days can last anywhere from 8 - 12 hours depending on his destination and any backhaul he may pick up. When not on the road, Pat is a corn and soybean farmer and very active in his community, serving as a volunteer firefighter, a certified firefighting instructor and member of the Glidden (Iowa) City Council. Recognized as a National Driver All-Star by NPTC in 2019, he was also an NPTC Hall of Fame Runner-up in 2019.



#### WAYNE HAYES AutoZone, Inc.

Wayne has driven 4.1 million miles in a driving career that has spanned 38 years. He began his driving career 38 years ago when he went to work for Turner Dairy Company hauling milk and ice cream.

Ten years later, in 1994, he joined AutoZone, where he has achieved mor than 3.1 million miles hauling auto parts to company stores. In his time with AutoZone, Wayne has made thousands of store deliveries without ever having a preventable collision, safety violation or a speeding ticket. He works 14 hours daily, a 70-hour work week. He drives on average 425 miles per day and 2,200 per week making deliveries in the southeast region. In 2020 he was the first AutoZone truck driver to log over 3 million safe miles driven. Wayne received AutoZone's Driver of the Year award in 2021. He has received numerous Extra Miler awards for various achievements. Wayne also received an award for his perfect attendance for his 28 year career with AutoZone.

In 49 years behind the wheel, Billy has driven 3.8 million miles, without a preventable accident. He started his career at age 16 working for his father's trucking company, driving dump trucks

hauling gravel in support of the family septic business. With trucking in his veins, he went to work for Spevco, hauling show cars and racing products in support of NASCAR. He joined UNIFI in 1999 and has worked there for the past 22 years with a brief two-year interlude when the company reoriented its business. In that amount of time, he has driven 1.9 million miles without an accident or moving violation. He currently works between 50-55 hours per week, averaging 10-12 hours per day and running about 1,800 miles per week hauling between the company's plants in North Carolina, South Carolina, Virginia, and Georgia. Last year he was recognized as the North Carolina Trucking Association Driver of the Year.



#### JEFFERY PUTSKEY **Brakebush Transportation, Inc.**

Jeff was born into the trucking business. Jeff's father was a truck driver for Weiland Trucking out of Wautoma, WI and Jeff began his career working around the yard at Weiland's. He officially joined

the company 39 years ago hauling beer, cheese and soda for Weiland. In 1993, he joined Brakebush Transportation and started hauling finished chicken product for human consumption. Back then, the chicken was floor loaded mainly by hand. Jeff has operated in all of the lower 48 states and has been running out West for most of his career with Brakebush. In the 39 years behind the wheel, Jeff has generated 4.3 million miles all without an accident and just one moving violation. # 2022 BENCHMARKING SURVEY UPDATE

ATER THIS MONTH, NPTC WILL RELEASE ITS 2022 BENCHMARKING SURVEY REPORT, which is sponsored by Penske Truck Leasing. The report will examine a number of key operational, performance issues and is designed to validate private fleet performance based on comparative peer data; to identify areas of improvement and opportunity; and to highlight significant trends affecting private fleet practitioners.



The benchmarking survey delves into key operational areas such as safety, technology, driver turnover, compensation, operational costs, equipment and maintenance to identify key trends and best practices.

As in previous surveys, the most common reasons for operating a private fleet are (1) to gain direct control of transportation capacity on demand, (2) to control costs, and (3) to provide consistent and high-quality customer service.

Private fleets stand out as a dynamically growing transportation market. The largest sector of the trucking industry, they account for approximately 50% of all Class 8 truck sales, and own or lease some three out of four Class 4 through Class 8 trucks on the road. Around 40% of all leased trucks are to private fleet companies.
