#### National Safety Conference Set for September 6-8 in Orlando

HE NATIONAL SAFETY CONFERENCE, presented by the National Private Truck Council each year, is the Council's premier safety leadership forum for best practices and innovations in the private fleet industry.

The core purpose of the conference is to provide attendees with proven safety man-



agement protocols, the most relevant benchmarking metrics, the latest safety technologies, and most "new and improved" operational tools to maintain high safety standards for their fleets.

This year's event will be held once again at the Omni Orlando Resort at Champions Gate, Florida, from September 6-8, 2023. More than 325 private fleet safety professionals and some 50 exhibitors are expected to register, representing a broad spectrum of fleet and allied/supplier practitioners.





#### INCREDIBLE CONNECTIONS

T THE NPTC 2023 ANNUAL CONFERENCE IN MAY, THE WINNER OF THE "TOP CTP GRADUATE" AWARD WAS Arvin Zabalerio, CTP, Sr. Manager of Logistics, Distribution, and Transportation for Pepsi Beverages Company. The award is sponsored by Fleet Owner magazine and presented each year to the candidate with the highest score on the CTP Examination.

An eight-year employee of PepsiCo, Arvin began working for the company right out of college. His jobs have included a range of specialties: manufacturing management; Process Improvement Engineer; Contract Operations Supply Planning management, and most

recently Logistics, Distribution, and Transportation management.

In his current position, Arvin manages a team of 130 private fleet drivers at 11 locations delivering shipments in and out to 40 buildings. He oversees a support staff of 16 salaried associates and an annual budget of \$86 million.

Raised in Morris County, New Jersey, Arvin imagined a career in acting when he was in high school. He starred as the lead in school musicals, from Leading Player in "Pippin" to the titular role in "The Wiz". "Theatre was a passion of mine and for a while I thought I was destined for acting school.

Things work out differently, however." He was selected to attend a magnet school, The Academy for Math, Science, and Engineering in Rockaway, New Jersey and graduated with a class of 22 students. "Engineering is problem solving and truly an exercise in critical thinking."

Hard work and dedication paid off. Arvin was the recipient of the four-year "full ride" merit-based Rutgers University Presidential Scholarship. This is the most prestigious scholarship available to undergraduates at the university. Arvin earned a perfect 4.0 GPA, graduated with Summa Cum Laude honors, and received the "Out-

standing Engineering Scholars Award" for the highest grades in his class. He finished with a B.S. degree in Chemical Engineering along with a minor in Social Psychology.

Incredibly, Arvin found time to join the Engineering Honor Society, the Chemical Engineering society, and sing in the Rutgers Casual Harmony (all-male a cappella) and co-ed Rutgers OrphanSporks a cappella. A Cappella music had been an integral part of his college career, and he turned his passions into something even bigger.

Today, he serves as an a cappella producer and curates vocal

competitions for collegiate groups across the Northeast region. He has served as an adjunct instructor for Organic Chemistry at The Office for Diversity and Academic Success in the Sciences (ODASIS) at Rutgers and earned a credential in "The Science of Well Being" from Yale University. Arvin is the author of a book, "Singular Intentions" (available at Barnes and Noble) written during the COVID pandemic in 2020. It's an account of gratitude and intentions: "a glimpse into my journey to live every day intentionally and the lessons I learned in the worst year of our modern generation."

Arvin's interests are fitness, music, singing, beatboxing, travel, and leading a motivated and positive lifestyle. He is also very passionate about social psychology which, as noted, he studied in college.

"People are my strength, and our drivers are a key focus of mine. Our people are the key" says Arvin. "I have made developing people a part of my brand." He further details, "I love transportation, and I love building successful teams. Participating in the PFMI and CTP programs ramped up my enthusiasm even further."

Arvin's manager, Cathy Ratchford, CTP, Senior Director, PBNA North Division, encouraged him to attend PFMI and earn his CTP Continued on next page

designation. "Cathy is a CTP champion. I was one of twelve candidates selected from Pepsi to attend, and I truly appreciate Cathy's leadership. She embodies the "People First" mindset and it is clearly shown with her sponsorship of our team in continuous improvement."

"I have made incredible connections at PFMI," says Arvin. "As organizations, we shouldn't have to re-invent the wheel. It has been wonderful to be able to talk to other members on best practices, driver topics, simplifying solutions, etc. The leadership of PFMI and faculty members exceeded my expectations. The insightful conversations I had with different people from all backgrounds were better than I could have imagined and were perhaps the ultimate take-away from the experience."

HE NPTC 2023 BENCHMARKING SURVEY REPORT, AN EXCLU-**SIVE MEMBERS-ONLY BENEFIT** sponsored by NPTC Five-Star member company, Penske Truck Leasing Company, will be officially published on August 1, 2023.

The Report is widely regarded as the foremost authoritative resource of private fleet practices in the United States and one of the most valuable benefits of Council membership. This publication has become the "gold standard" by which private fleets assess, justify, and scorecard their performance and continuously improve their operations.

"This Report is an especially valuable part of NPTC services," says Steven Roberts, CTP, member of the NPTC Board of Directors and Fleet Manager of Deseret Transportation, the private fleet of the Church of Jesus Christ of Latter-Day Saints. "It gives us a deep dive into our own operations as compared to other fleets."

Confidentiality and trust are hallmarks of the Report. Information collected from participating fleet companies is treated as privileged and proprietary and never discussed or shared within or outside NPTC. Aggregate data shown in the report itself is anonymous and made without attribution as to individuals and their corporate affiliations.

NPTC retains sole and exclusive management control of the report including the survey questionnaire, data collection, analysis, production, and distribution to participating fleet companies. For the first time, the survey questionnaire was offered this year in an electronic format designed exclusively for the Council to ease the process of data submission and further enhance security.

Produced under the leadership direction of author and general editor, Tom Moore, CTP, NPTC Executive Vice President, the report has evolved over the years into the largest and most comprehensive research project ever conducted on private fleet best practices and operational protocols.

To augment the value of the report, Mr. Moore will, upon request, provide participating individual fleets with customized "data pulls" which show how their fleet compares with other peer fleets operating in the same business sector, as well as to show how their fleet's data stacks up against national trends and norms.

The Council wishes to recognize members of the NPTC Benchmarking Survey Committee, made up of fleet member company representatives and NPTC Staff. The committee assists in making numerous improvements including building more diverse content of fleet operating practices and allowing for a greater range and depth of key metrics.

## NPTC WELCOMES FOUR INTO **DRIVER HALL** OF FAME

OUR DRIVERS, WHO COLLECTIVELY HAVE DRIVEN FOR MORE THAN 172 YEARS WHILE RACKING UP NEARLY 12.5 MILLION MILES OF SERVICE without a chargeable accident or a moving violation, have been inducted into the NPTC Driver Hall of Fame sponsored by International Truck. The recognition took place in conjunction with the NPTC Annual Education Management Conference and Exhibition, which was held May 7-9 in Orlando, Fla.

The drivers are from NPTC member companies and have met the minimum qualifications of 20 years, three million miles or 50,000 hours of driving without a preventable accident. Many of the drivers have far exceeded these qualifications and are known for having made significant contributions to their industry and their communities. Since its inception, 116 drivers have been installed in the Driver Hall of Fame. This year's Driver Hall of Fame inductees are:



#### **CLAUDE RICKY COOK Shaw Industries Group**

Ricky started driving professionally in 1979 and in 41 years behind the wheel (the last 38 of which have come with Shaw Industries), he has racked up 4.4 million miles (4.1 million with Shaw) without a

preventable accident or a moving violation. Ricky learned to drive at Watts Dairy Farm driving a single-axle tractor pulling soybeans in a grain trailer. While at Watts he obtained his chauffer's license. Watts Dairy also owned Southern Amusements where Ricky worked from 1979-84 driving a service truck hauling arcade games. Today, Ricky works 11 hours per day, four days a week operating in the north Georgia area. His main route is moving product from the rail yard to the Shaw facility in Chickamauga, while also servicing other Shaw facilities throughout the Dalton area.



#### **RONALD MAHAR** Walgreen Oshkosh, assigned by CPC Logistics

In 54 years behind of driving, Ron has driven four million miles without an preventable accident, injury or moving violation. He learned to drive on the

farm driving the old farm tractors. When he enlisted in the U.S. Army, he was trained as a mechanic and was able to drive all kinds of different equipment. He started driving trucks in the Army because there were no other drivers qualified to operate heavy equipment. When he returned from active duty, he worked for a several companies as a driver before moving to Texas and going to work for CPC Logistics, assigned to the Walgreen's account. In 33 years there, he has racked up more than 3 million safe driving miles. 8-10 hours a day driving- about 2200-2300 miles a week. He used to peddle freight delivering to Walgreen's stores throughout Texas, Today, he is running relays between warehouse locations in Houston and Dallas, 8-10 hours a day or about 2,200-2,300 miles a week.

Chris has championed many safety and training programs that include the installation and proper use of liftgates; proper loading and unloading techniques; and driving in inclement weather.



#### **BILLY STEELE UNIFI** Manufacturing

Billy started his driving career 42 years ago with Burlington Industries operating a straight truck and delivering product to the plants. Now in his second stint with Unifi, he has accumulated 3.1 million

miles without a chargeable accident or a moving violation. He currently works 50 hours a week, driving 300-400 miles per day throughout North Carolina and Virginia, moving product between plants and delivering to customers. His attitude along with his defensive driving skill helps him to be a safe driver. He has earned 17 Years of Unifi Safe Driving Awards and was named the Driver of Month by the North Carolina Trucking Association in 2019.


