

IVEN THE ONGOING UNCERTAINTY OF THE COVID PANDEMIC, with growing shutdowns, group meeting restrictions, and lingering questions about the availability of preventive vaccines, the NPTC Executive Committee elected to **CANCEL** the **CTP Exam Prep Workshop scheduled for January 15, 2021** in Jacksonville and the **Private Fleet Management Institute, scheduled for January 16-20, 2021**, also in Jacksonville. The decision is made with an abundance of caution with the safety and health of our attendees being paramount. All registration fees paid will be refunded in their entirety for both events.

We will conduct the CTP Exam as scheduled on Saturday, February 13, 2021, as it will be self-administered and virtual. NPTC has announced the schedule for online CTP exam preparation sessions to be held in January (*see page 5*); these sessions will be available to 2021 CTP Exam candidates at no charge. In addition, this year's CTP candidates will be offered a mentorship program, also at no charge.

The NPTC 2021 Annual Education Management Conference & Exhibition has been RESCHEDULED for Sunday through Tuesday, June 13-15, 2021 at the Hilton Cincinnati Netherland Plaza Hotel and Duke Energy Convention Center. He was born on an Army Base in Fort Irwin, California, and soon moved with his family to the Cleveland/Akron area where he grew up. In high school, he was a three-sport athlete in football, wrestling, and baseball. He enrolled at Youngstown State University, a Division 1AA school, where after qualifying as a walk-on candidate, he played four years of football as a middle linebacker, earning All-American honors.

Pat was later invited to tryout camps in the Canadian Football League and NFL. Pat finished his academic eligibility at Malone College where he graduated with a B.A. degree in Business Administration and Management. Married for more than 30 years, Pat and his wife have children and grandchildren.

Pat's first job out of college was as a warehouse manager for a fast food distributor servicing national account restaurants. He later worked in distribution warehouse management for the Marriott Corporation. In 1998, he joined T. Marzetti Company as Distribution Center Manager and helped build a 200,000 sq. ft. facility.

Over his more than two decades with the company, Pat has served as private fleet manager, plant manager, distribution warehouse manager, director of freight & warehousing, and since 2019, as Logistics Execution Leader—special projects.

T. Marzetti Company is the Specialty Food Group of the Lancaster Colony Corporation. It is a publicly traded business with \$1.3 billion in annual sales with 16 manufacturing locations and 2 distribution centers. Marzetti produces a long list of salad dressings, fruit and vegetable dips, frozen bread and baked goods, noodles, and croutons—to name a few products. It is the largest food and beverage company headquartered in Central Ohio. The company started out as an Italian restaurant in Columbus, Ohio, by Teresa and Joseph Marzetti, recent Italian immigrants who arrived in America in the late 1800s. Marzetti became a local favorite especially among Ohio State University students and grew to become a four-star restaurant.

By 1955, the Marzetti's upstairs kitchen of the restaurant became a full-scale factory, and the Marzetti brand of salad dressings found its way into grocery stores throughout Ohio. After Teresa's death in 1972, the restaurant closed, but the company and factory continue to today. The company also makes private label products for retail & foodservice national brand chains.

The company's private fleet consists of 33 drivers—21 over-theroad and 13 handling city runs. Pat says the Marzetti customers are best serviced by the private fleet. Their drivers are highly regarded by management and are well paid under a pay-for-performance program which includes meeting exceptional safety standards. "We have done a good job keeping up our fleet," says Toler. "As a team, drivers average 16 years of tenure with the company. The fleet itself is on a course of continuous upgrade and improvement."

Pat got involved with NPTC about ten years ago. "I found NPTC on my own, searching the internet for private fleet training. The Private Fleet Management Institute caught my eye. After getting approval from my boss, I enrolled in the 2011 PFMI. The sessions were excellent and the networking was really good with people from strong private fleet backgrounds. Over the years, I've kept up with dozens of managers I met at PFMI and see regularly at the annual conference. We hope to have more of our transportation people go through the program in future years."

Pat graduated with the CTP Class of 2011, and has been actively involved with the Council ever since. He has been a regular speaker at the NPTC annual conference which he describes as a "great resource."

He was elected to the NPTC Board of Directors in 2019.

NPTC ANNOUNCES 2021 SAFETY AWARD APPLICATIONS

PTC OFFERS TWO DIFFERENT WAYS IN WHICH YOUR FLEET AND YOUR DRIVERS CAN BE RECOGNIZED for their commitment to improving highway safety:

FLEET SAFETY AWARDS: These awards recognize fleets for outstanding and/or improved safety records based on their crash rates. First, Second and Third Place awards are given for Large and Small fleets in each of the three operational categories (local, regional, mixed). These awards also present Gold, Silver and Bronze Seal Certificates to private fleets with locations that have reduced their vehicle accident frequency rates. Applications must be postmarked by Monday, March 1, 2021.

DRIVER HALL OF FAME: The NPTC Driver Hall of Fame honors four exceptional drivers each year who are inducted into this elite group. The minimum qualifications – a driver must have driven three million miles, 20 years or 50,000 hours with no preventable accidents. Drivers must be a regularly-employed full-time, leased, or dedicated driver of an NPTC member company who is actively driving until time of induction. Applications must be received by Monday, March 1, 2021.

CTP Recertification

T ITS FOUNDING AND FROM THE TIME OF ITS CHARTER CLASS GRADUATION IN 1993, the National Private Truck Council's Certified Transportation Professional (CTP [®]) program's guiding vision was to create a widely recognized and respected credential of professional achievement for private fleet managers and suppliers. By earning your Certified Transportation Professional (CTP) designation, you joined a group of transportation professionals who have made the commitment to the private fleet industry, to an ongoing pursuit of career advancement, and to continuous enhancement of the necessary knowledge and skills. You should feel proud of the accomplishment you have achieved for both yourself and your company and a designation you will want to keep for your entire career.

In order to maintain your certification in the program, there are several points you must remember:

CTPs must recertify every three (3) years;

•50 recertification points must be earned during the 3-year period (to check your current point balance and recertification year cycle, <u>click here</u>);

A Recertification Application need only be filed once during the 3-year period to register recertification points or may befiled annually; and,

Recertification Applications are available for completion online. (For a matrix of opportunities to earn points, <u>click here</u>).

Earlier last month, you received your annual **\$100 invoice required to maintain active status**. While your company may pay your annual \$100 fee, ultimately you are responsible for payment of this fee as the certification is a personal designation. You can pay your \$100 CTP annual fee *online here*.

Aside from the prestige of holding the industry's highest certification achievement, CTPs receive:

- The NPTC Weekly Update, a timely, comprehensive summary of current legislative and regulatory issues that affect private fleets
- More educational programs that reach beyond your current level of achievement and allow for continued advancement
- Increased opportunities for networking with fellow CTPs
- Access to our Training and Certification specialist to answer all questions relating to private fleet operations
