### GRADUATE OF THE CERTIFIED TRANSPORTATION PROFESSIONAL (CTP®) PROGRAM, CLASS OF 2022, Ed Reardon, CTP

Senior General Manager for Fleet Safety and Compliance, CF Logistics, LLC, began participation in NPTC just under three years ago. Since that time, he has become one of the Council's "rising star" volunteers as a frequent speaker and expert fleet management presenter at NPTC's Annual Conference, National Safety Conference, and Webcast Series.

"I knew about NPTC and the CTP program through a former colleague who gave me his CTP Resource Study Guides," said Ed. "I got involved in NPTC as part of a 'deal' with my employer. When our two companies merged, I requested that the new company become a member of the Council and I be allowed to go through the Certified Transportation Professional program."

As soon as CF Logistics joined NPTC, Ed enrolled in the CTP Exam Prep Workshop. "The prep course was exceptionally thorough and really helped me focus. After that, it was all studying on my own since I couldn't break away from work to attend the Private Fleet Management Institute. I cracked the books for several weeks and, fortunately, passed. It was a great experience and very challenging—to say the least—but I would not want to do it again."

Ed was born in Philadelphia and raised in South Jersey. He enrolled in a local community college after high school, transferred to Glassboro State Teachers College (now Rowan University), and then enlisted in the service. However, Ed didn't walk cap and gown until many years later. He graduated from Thomas Edison University at the age of 53. As a military veteran, Ed served in the United States Coast Guard for several years with honors and commendations.

Before getting into the trucking business, Ed worked a few years for Wells Fargo at night as an undercover investigator of cases involving employee theft. His next job was in retail management

working for pharmacy chain stores where he helped train store managers. He "lucked into" trucking almost by happenstance.

"My dad was in trucking all his life. Before retiring as a terminal manager, he offered me a position working nights loading trucks. After a while, I switched to long-haul truck driving." Ed was an OTR professional for 22 years and drove around 2.5 million miles without an accident or driving violation. He and his father later owned their own hauling business, providing home deliveries for Sears and Roebuck. Ed also owned a landscape business for nine years.

"I eventually decided that fleet management was where I wanted to be," says Ed. He maintains a valid Class A CDL License and earned a Certified Smith System Instructor Certificate. These credentials and his exceptional record as a driver qualified him as a driver trainer/outside contractor helping companies build teams of professional drivers. Ed was responsible for putting into service the first 37 drivers working for the private fleet of a major grocery supermarket chain.

Ed has been in his current job for seven years. He oversees the safety and compli-

ance of a private fleet consisting of 88 drivers and 227 tractors and reefer trailers. Involvement with NPTC has brought many benefits to the fleet's operation. "Our return-on-investment has been unbelievable—more than ten-fold in a few years," says Ed.

"The contacts I have met being a CTP are nothing short of phenomenal. Engagement with the NPTC culture means going far beyond your own four walls. I have found being a frequent speaker is a very rewarding learning experience in and of itself. I get great take-away insights listening to other presenters and members of the audience. You really must be on your game to present at an NPTC event."

Ed took advantage of services provided by NPTC General Counsel, Rick Schweitzer, when his employer was going through the merger process. "Rick laid out a plan of action for us to follow and

it worked perfectly. I can't stress enough the value that Rick brings to the NPTC membership. I faithfully follow his monthly Washington Report to stay on top of legislative and regulatory changes going on in the industry.

# “Best Show of the Year”

## NPTC 2024 expects record turnout

**T**HE NATIONAL PRIVATE TRUCK COUNCIL'S NPTC 2024 ANNUAL CONFERENCE AND EXHIBITION IS PROJECTED TO DRAW ANOTHER RECORD-SETTING NUMBER OF PRIVATE FLEET PROFESSIONALS. The event will take place April 21-23 at the Hyatt Regency Orlando and Orange County Convention Center. Registrations are expected to exceed last year's all-time high of 1,325 attendees. Representatives from more than 180 supplier/ vendor companies will exhibit at the show.

Education and networking are the event's core focus. NPTC's Conference Planning Committee, made up of some 50 fleet and allied/supplier company representatives, has been at work over the past several months selecting top speakers and subject-matter content for breakout sessions and workshops.

Over three days, 45 fleet expert practitioners will present and moderate more than three dozen sessions with discussions on topics of current interest to private fleets. Breakfast best-practice roundtable meetings in back-to-back mornings will take up over twenty specialty topics, each coordinated by an expert moderator.

Highlighting topics will include: “net zero” policy mandates for trucks set by government regulation; a review of “clean truck” legislation passed in California and several other states; a truck industry coalition advocating for sound public policies in the transition toward zero-emissions; and insights into EV adoption strategies from a major utility company with a large private fleet.

Other subjects on the program include driver performance systems; integration of onboard telematics; lessons in recruiting, interviewing, and onboarding the new driver; equipment availability and extended trade cycles; maintenance and total cost of ownership; competitive compensation and benefits in today's market; automated trucking; driver coaching and videos; the role drivers play in spec'ing equipment; and fleet justification strategies.

The schedule begins Saturday evening, April 20, with an invitation-only **WELCOME RECEPTION**, sponsored by Penske Truck Leasing, which will recognize first-timers and the CTP Class of 2024. Sunday morning, April 21st, starts off with concurrent workshops featuring NPTC general counsel, **Rick Schweitzer**, presenting the Washington Report, sponsored by Centerline Drivers LLC. **FLEET SAFETY AWARDS:** These awards recognize fleets for outstanding and/or improved safety records based on their crash rates. First, Second and Third Place awards distinguish fleet companies in the operational categories of Local, Regional, and Mixed. These awards also present Gold, Silver and Bronze Seal Certificates to private fleets with terminals that reduced their vehicle accident frequency rates. Applications must be received by Friday, February 2, 2024.

**DRIVER HALL OF FAME:** The NPTC Driver Hall of Fame honors four exceptional drivers each year who are inducted into this elite group. Driver applicants must meet the minimum qualifications of three million miles, 20 years or 50,000 hours with no preventable accidents. Drivers must be a regularly-employed full-time, leased, or dedicated driver of an NPTC member company who is actively driving until time of induction. Applications must be received by Friday, February 2, 2024.
